

Official Rules

Teacher Appreciation Amazon Wishlist Giveaway – October 17-31, 2022

Please read these rules before entering the TTCU Giveaway (the "Contest") presented by TTCU Federal Credit Union (referred to herein as "TTCU", "We" or "Our"). You (the participant in the Contest "You" or "Your") agree that, by submitting an entry, You will be bound by these Official Rules and You acknowledge that You satisfy all contest eligibility requirements.

Eligibility. If You are currently employed as a teacher in Oklahoma and at least 18 years of age at the time of entry, You are eligible to enter the Contest. No purchase is necessary for entry. Officers, employees, and agents of TTCU, the Contest's other participating sponsors (if any) and their advertising agencies (if any), and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

How to Enter. You may enter the Contest by filling out a form linked on the specific contest social posts (on Facebook, Instagram, Pinterest, Twitter, LinkedIn or on ttcu.com) during the times below. The contest posts will be available the following days, at the following times:

- From 9:00 a.m. on **Monday, October 17, 2022**, to 11:59 p.m. on **Monday, October 31, 2022**

Limit one entry per user by filling out a form linked on the specific contest post (Facebook, Instagram, Pinterest, Twitter, LinkedIn or on ttcu.com). All times noted herein are Central Time.

Prize. We will award seventy (70) total prizes. Winners will be awarded randomly from the fully completed forms submitted from any of the contest posts. Each prize will consist of a gift (up to \$50 in value, including shipping), chosen from the teacher's Amazon Wishlist.

Prize Drawing. Winners will be selected and notified via email between November 1-19, 2022.

Odds of Winning. Odds of winning depend on the number of eligible entries received.

Additional Terms. We may, to the maximum extent permitted by applicable law and in Our sole discretion, change these rules or cancel the Contest at any time; or modify, terminate, or suspend the Contest for any reason or other causes beyond our control that corrupt or impair the administration, security, fairness or proper play of the Contest or submission of entries. We are not responsible for: (a) lost, misdirected, late, incomplete, or unintelligible entries or for inaccurate entry information; (b) any printing or typographical errors in any materials associated with the Contest; (c) any error in the operation or transmission, theft, destruction, unauthorized access to, or failure to receive any entry information on account of technical problems or traffic congestion. We may, in our sole discretion, disqualify any individual found to be: (i) tampering with the entry process or the operation of the Contest; (ii) acting in violation of these rules; or (iii) acting in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person. If Your entry is incomplete your entry will be void. No greater than the number of prizes stated in these Official Rules will be awarded. If any technical errors occur in the selection of potential prize winner or if more prizes are claimed than the number of prizes being awarded as provided in these Official Rules, We may award the prize by random drawing from among all eligible claimants.
